## 1. CALL TO ORDER:

**a.** Welcome – Chair Audette called the meeting to order at 12:00 P.M. and welcomed all in attendance.

**b.** Citizen Comment Period – No citizen comments were made.

### 2. REVIEW / APPROVAL OF MINUTES

Mr. Audette asked if there were any changes, deletions, or comments to the minutes of the November 18, 2023 meeting. Mr. Audette then made a motion to approve; this was seconded by Mr. Carnes and unanimously approved.

### 3. PROPOSED POLICY COMMITTEE ACTION ITEMS

a. SC 160 / I-77 Interchange Reconfiguration Project – Mr. Hooper provided an overview of the planned project; specifically, both the interchange and corridor widening components. Mr. Hooper highlighted the critical evaluation steps in the process resulting in the recommended configuration from the alternatives analysis process. Discussion then followed regarding the range of expected operational benefits to be realized. Mr. Hooper then covered the historical evolution of cost variables and the utilization of a "join project programming" approach that includes an award from the State Infrastructure Bank; RFATS Guideshare Funding; and supplemental funding from York County. Lastly, Mr. Hooper reviewed the working schedule of upcoming project activity provided by the SCDOT Project Management Team.

Discussion then followed regarding the benefits and challenges of undertaking this type of network improvement and the significant budgetary commitment that the RFATS Policy Committee has provided this project. As a point of reference, Mr. Hooper then noted increased budgetary flexibility offered by Secretary Hall to make available an additional year of Guideshare funding in order to ensure that all other

project priorities will be able to maintain their established schedule should the need materialize. Ms. Cox then made a motion to approve; this was seconded by Mr. Carnes. Mr. Sutton then requested that the motion be amended to have the email confirmation that this additional funding flexibility (i.e., email correspondence from Sec Hall) be reflected in the meeting minutes. An amended motion was then made and unamiously approved. **\*\*Requested Email from Secretary Hall Attached\*\***

**a.** Next Meeting – Mr. Audette noted that the next Policy Committee meeting is scheduled for January 26, 2024.
