TRANSPORTATION CONFORMITY DEMONSTRATION: 2008 OZONE NATIONAL AMBIENT AIR QUALITY STANDARD

The purpose of this amendment is to document continued compliance with the provisions of the Clean Air Act (as amended) and the Fixing America's Surface Transportation Act. The conformity determination for the 2035 Long Range Transportation Plan (LRTP) and FY 2014-2019 Transportation Improvement Program (TIP) are based on a regional emissions analysis that utilized the transportation networks in those plans and emissions developed by the S.C. Department of Health & Environmental Control (SCDHEC). All regionally significant federally funded projects in areas designated by the United States Environmental Protection Agency (EPA) as air quality non-attainment or maintenance areas must come from a conforming LRTP and TIP.

When this conformity determination was originally completed in June 2013, there were three principal triggers necessitating this action: (1) transportation conformity is required to be performed every four years as a component of the LRTP/TIP update process; (2) a conformity determination was also required within one year of the effective date of the 2008 ozone standard (required by July 20, 2013); and (3) a conformity determination was required within 24 months of the effective date of the Environmental Protection Agency's (EPA) finding of adequacy for the motor vehicle emissions budgets (MVEBs), as was submitted in the re-designation and maintenance plan for the 1997 8-hour ozone standard (required by October 9, 2014). The 2013 conformity analysis satisfied all three of these requirements

INTERAGENCY CONSULTATION

Interagency consultation is central to the entire transportation conformity process. It serves as the underpinning for conformity determinations and as the primary mechanism for ensuring early coordination and negotiation between all parties affected by transportation conformity. The conformity determination must be made according to 40 CFR §93.105-(a)-(2) and (e) and the requirements of 23 CFR 450 (40 CFR §93.112, Criteria and Procedures).

The RFATS MPO coordinated its activities for this amendment to our conformity report for the 2035 Metropolitan Transportation Plan with the Federal Highway Administration (FHWA), Environmental Protection Agency (EPA), South Carolina Department of Transportation (SCDOT), York County, as well as the South Carolina Department of Health and Environmental Control (SCDHEC). All meeting minutes and agency comments related to this amendment are reflected in **Appendix B**.

PUBLIC PARTICIPATION

The RFATS MPO has an established Public Participation Plan which outlines specific procedures for ensuring that public participation is a core component of the transportation planning process. Public participation takes many forms, and RFATS' uses a wide range of methods and approaches to secure meaningful public input.

In addition to general stakeholder identification and outreach, RFATS has established a Citizens Advisory Committee (CAC) to expand the range of general citizen input into the organizational structure of the MPO as a part of the transportation planning process. This standing committee meets regularly to review and provide comments to the RFATS Policy Committee as appropriate. All submitted public comments related to this amendment are reflected in **Appendix C**.





Items Discussed:

1. (DH) Initiation of a conformity amendment on the US 21 / SC 51 Pennies project;
 - a. (DH) Road will not be opened to traffic in 2015 so it will need to be pushed to 2025 Horizon year.
 - b. (DH) Will need to look at all projects as there appears to be about six other projects that may need to move model years. Four of them are 2-lane to 3-lane projects. The other two are 2-lane to 5-lane projects.
 - c. (LC) Due to time needed for modelling and other workload requirements scheduling will be difficult.
 - d. (DM) Pending the timing of DHEC's redesignation request approval, DHEC may need to run MOVES 2014 versus 2010(b)
 - e. (DH) Policy Committee meets September 25th then again in November.
 - f. (JH) Present for information only. Run models and have Public Comment late Sept – early October. Seek approval of new finding in November.
 - g. (HP) Use an opportunity at an upcoming Policy Committee meeting to stress the importance of scheduling.
 - h. (DH) Will revise the spreadsheet and send to Michael Dennis for Travel Model runs.
 - i. (LC) Will send out request for input parameters to MOVES model.
2. (JH) Conformity Amendment #5 was approved by EPA and is now headed to FTA.
3. (DM) SC's redesignation request is in the signature approval process. No specific timeframe for when it will be finalized. It will include Conformity Maintenance requirements. EPA received adverse comments from Sierra Club regarding NC's redesignation request.
 - a. (RJ) EPA could not begin approval until base year emissions approval went into effect (8-11-2015)
 - b. (RJ) NC had a 21 day comment period.

Conformity Amendment #6

US 21 / SC 51 was originally modeled as open to traffic in 2015. This project will not be opening to traffic by the end of the year and will therefore be crossing horizon years, triggering a conformity amendment. This change prompted a more holistic review of the projects slated to open to traffic in 2015 and after the review, it has become apparent that five projects (both exempt and non-exempt) will not be open to traffic in 2015 and should be reflected appropriately in a conformity amendment since one is to be undertaken by RFATS. The discussion on this topic mainly revolved around what horizon years to model under the new conformity amendment. Traditionally RFATS has modeled 2015, interpolated 2022 (a budget year), modeled 2025, and modeled 2035.

The group discussed that since the 1997 standard was vacated, the RFATS no longer has to model 2015, however, 2022 is currently interpolated off of 2015, the RFATS would either have to continue to run 2015 to do the interpolation, or they could do a modeled run for 2022. It was also discussed that NCDOT may have already done a run for 2022.

The group also discussed the potential schedule for this amendment being analyzed and modeling completed in September 2015 with a 30 day public comment period. The RFATS Policy Committee would then likely take action to approve at the November 20, 2015 meeting. The resolution and conformity amendment would be sent to FHWA and FTA in late November 2015. FHWA and FTA would start the 30 day review period for EPA in early December 2015, and barring no federal agency comments/concerns, a projected approval period in early January 2016. This schedule is dependent upon RFATS being able to run an analysis on the 2022, 2025, and 2035 horizon years. Confirmation that if there was no change to 2025 and 2035, those horizon years did not need to be re-run was provided by FHWA and EPA. EPA confirmed that the 2022 run could be done with MOVES2010b. This confirmation is all dependent upon the current Maintenance Plan that is under review not being approved by EPA before the federal conformity amendment approval. If the Maintenance Plan is approved before the Federal approval in January, the RFATS conformity amendment will have to also account for the budget years contained within the Maintenance Plan. The Maintenance Plan will require the use of MOVES2014.

The follow action items will need to be address in order for the group to move forward appropriately -

- ***ACTION ITEM – SCDOT – Check to see if 2022 was a year that NCDOT had already run with the correct assumptions.***
- ***ACTION ITEM – EPA – Check to see when Maintenance Plan will likely be approved and forward schedule to the group along with Maintenance Plan budget years if relevant.***
- ***ACTION ITEM – DHEC – Provide a schedule for MOVES analysis based upon Maintenance Plan schedule if relevant.***
- ***ACTION ITEM – RFATS – Determine if another meeting of the IAC is needed based on action item outcomes.***

New Ozone Standard

The EPA is predicting a new Ozone standard publication by October 1, 2015.

DH . Summarized prior discussions regarding the pending conformity amendment at US 21 / SC 51 and the requested follow-up by EPA on the likely sequence of pending approvals (i.e., 2008 8-hr ozone maintenance plan MVEB\$).

DM . Stated that although a firm approval date has not been established, it is envisioned that the maintenance plan will be approved prior to the projected completion of the conformity amendment in January. With this in mind, staff discussion then followed regarding needed incorporation of the budgets from the 2008 maintenance plan. The timeline to determine budget adequacy was then summarized, noting the public comment component has already been completed.

As a point of reference, it was also noted that the approval of budget adequacy will not delay the pending redesignation request.

NR . Asked about the status of the redesignation?

JS . Stated that EPA is processing it and are working through a number of reviews the adequacy determination of the budgets

NR . What is the latest timeline on when this is likely to be completed?

JS . Briefly reviewed the typical components of this process, but noted that a projected completion date has not been established at this point. As a point of reference, JS noted that the receipt of adverse comments would extend the overall process in order to evaluate and respond.

ALL . Staff discussion then occurred regarding the modeling scenario for the pending conformity amendment and it was agreed that modeling outputs for 2022, 2025, interpolating for 2026 and 2035 will be utilized.

DH . Reviewed the established schedule for completing the conformity amendment and asked LC whether there is sufficient time to complete the modeling component so that the conformity amendment could be presented for preliminary approval at the Friday, November 20th Policy Committee meeting. In response, LC noted that sufficient time is available to maintain this schedule.

New Ozone Standard

The EPA is scheduled to announce the new standard on or before October 1, 2015.

DH . Briefly reviewed the air quality benefit analysis methodology that the IAC approved earlier this year for the FY 15-16 Congestion Mitigation & Air Quality Improvement Program. A summary of the AQBA results for this year's two project submittals was then reviewed. The specific locations include the intersection of India Hook / Celanese Road and Carowinds Boulevard / Pleasant Road.

HP . Asked about the project specific context at each location and generated outputs.

DH . Noted that India Hook / Celanese Road is located along a seven lane corridor leading to one of the most congested points for accessing I-77. It was then noted that Carowinds / Pleasant Road is located along a corridor that includes significant non-residential development where demand patterns show greater variation, but nonetheless represent a challenging operating environment.

DH . Then reviewed the draft documents for the pending conformity amendment covering updated project completion dates in horizon year 2025.

LC . As a point of reference, asked about the time period when the Charlotte area last updated their regional emissions spreadsheet.

MD . Noted that CDOT incorporated these project changes into their assumptions spreadsheet as part of completing their conformity amendment earlier this fall.

HP – Does DHEC have any update information that they can provide on the new ozone standard?

LC – Briefly referenced the numbers for 2015 versus the last few years and noted that York County continues to be expected to be in compliance with the 70 ppb standard. It was then noted that as past years currently taken into account are dropped off the applicable evaluation period, that levels in Charlotte might tend to be closer to the proposed new standard. As things continue to progress, additional updates will of course be provided to the IAC.


