## CHAPTER 4 HIGHWAY ELEMENT

The 2035 Long Range Transportation Plan is being amended to identify a specific funding source for an existing project in the 2035 LRTP. Specifically, the Cel-River Widening Project (from Cherry Road to Dave Lyle Boulevard).

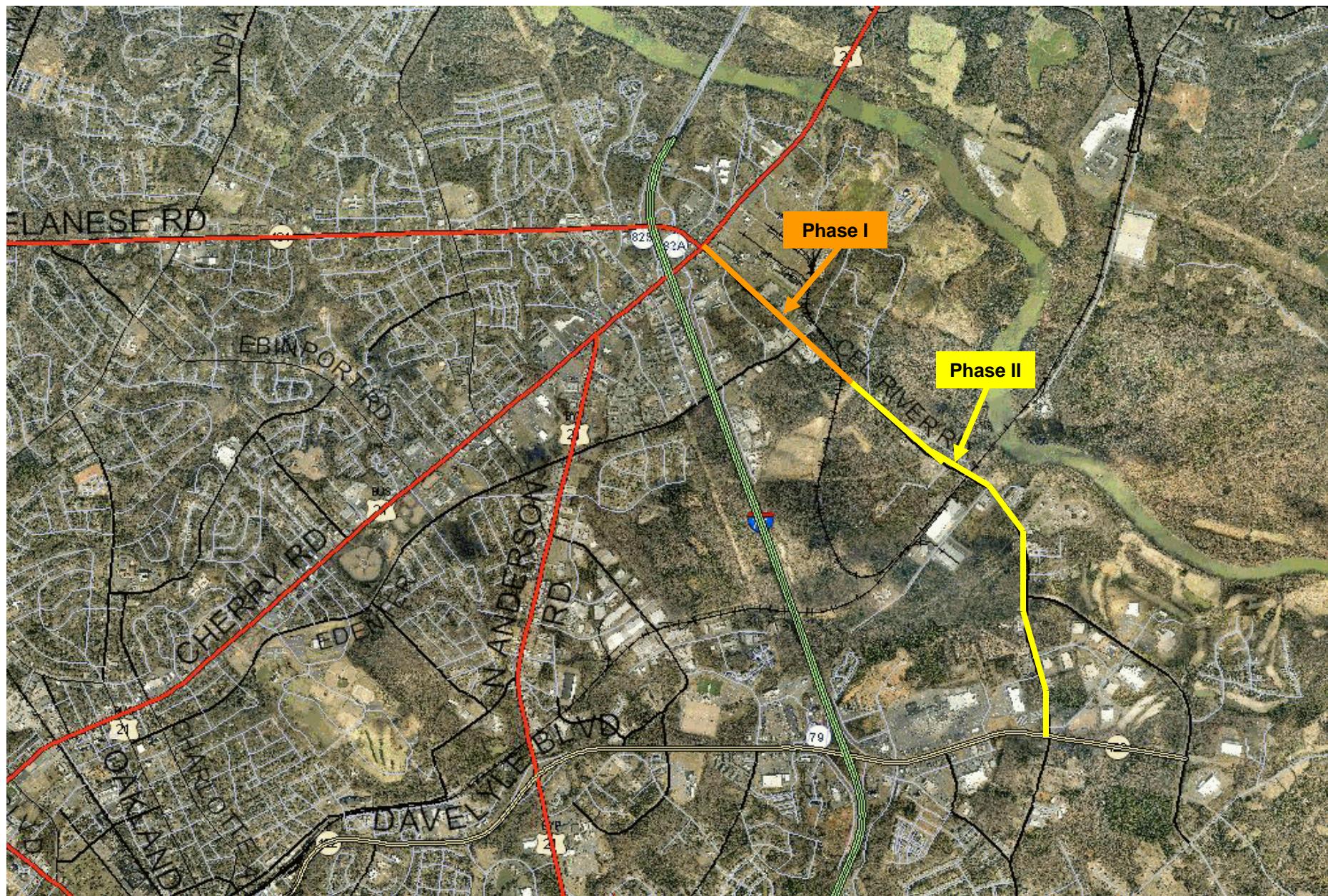
Cel-River Road is an existing two lane facility that will be expanded to five lanes from US 21 to Dave Lyle Boulevard – with an approximate length of 3 miles. This project was originally identified during the development of the 2035 Long Range Transportation Plan as an important, multi-phase project to improve the functionality between two principal arterials within the RFATS Study Area – Cherry Road and Dave Lyle Boulevard.

Both phases of this widening effort are currently reflected as an unfunded need in the 2035 Long Range Transportation Plan. With this in mind and based on recent guidance from the Federal Highway Administration, funding through the recently passed 2011 Pennies Program and a subsequent 2018 Pennies Program will serve as the principal funding sources for both phases of this project. Specifically, \$5,829,426 from the 2011 Pennies Round for Phase I and \$13,500,000 from a subsequent 2018 Pennies Program.

It should be noted that the current funding of Phase I of this project from Cherry Road to approximately 0.100 miles north of the Southern Eden Terrace Extension (S-645) is provided from the 2011 Pennies for Progress Program; but if other funding is identified for this work, then this funding could be utilized for work associated with Phase II of this project.

Lastly, it is also important to note that this project was modeled and included in the transportation conformity determination associated with the approved 2035 Long Range Transportation Plan.

## CHAPTER 13 FINANCIAL PLAN

### Introduction

In accordance with federal requirements, a Financial Plan should demonstrate the following: (1) that the costs of proposed transportation improvements identified in the RFATS 2035 Long Range Transportation Plan are consistent with projected revenues over the duration of the LRTP; (2) indicate resources from public and private sources that are reasonably expected to be made available to carry out the plan; and (3) that the LRTP show the cost of proposed transportation improvements in year of expenditure (YOE) dollars, balanced against the projected revenue stream.

### Funding Sources

**Table 4-2** shows the amended 2035 Long Range Transportation Plan projects and estimated total cost of the projects. This spreadsheet shows the different funding sources for the total RFATS LRTP project list. The following categories was added to **Table 4-2**:

- York County 2011 Pennies for Progress Program - \$5,829,426 for Cel-River Project (Ph I)
- York County 2018 Pennies for Progress Program - \$13,500,000 for Cel-River Project (Ph II)



**1. CALL TO ORDER:**

- A. **Welcome** – Chairman Funderburk called the meeting to order at 12:15 P.M.
- B. **Citizen Comment Period** – Chairman Funderburk invited visitors and/or citizens who had comments to address the Policy Committee at this time. There were no comments.

**2. REVIEW/APPROVAL OF MINUTES:**

Chairman Funderburk asked if there were any changes, deletions or comments to the minutes of the August 12, 2011 meeting. Hearing no comments, Mr. Reno made a motion to approve the minutes as presented. Dr. Blackwell seconded and the minutes were unanimously approved.

**3. UPDATE ON CURRENT PROJECTS:**

- A. **York County One Cents Sales Tax Program Update** – Mr. Leazer reviewed the funding and status of the 1997 and 2003 Pennies for Progress projects noting a total project cost of \$500 million for both programs. Specifically, 12 of the 1997 projects are complete; one is currently under construction (Hwy 5 Bypass); and one is scheduled for bidding at the end of 2011 (Hwy 72). The 2003 program consists of 38 projects with 12 complete; 7 under construction; and 9 under project design, permitting or ROW acquisition. Mr. Leazer also noted that 7 of the 2003 projects have been carried over to the 2011 Pennies for Progress program which consists of 26 projects (15 located within the RFATS area) with an estimated total cost of \$161 million.

Mr. Norman and Commissioner Nuckles inquired about the cost of utility relocation. Mr. Leazer stated that York County is participating with all utility companies to assist with the relocation costs for existing utility equipment- no upgrades – in the 2011 Pennies for Progress program.

**B. Express Bus Service Update** – Mr. Hooper presented the quarterly report for the CATS 82X Express Bus Service. Specifically, Mr. Hooper noted an average of 164 riders per day for the quarter which represents an approximate 1% increase from the average quarterly ridership in FY 2010-11. Mr. Hooper then noted that the trend line for 82X is stable with a moderately upward bias. Mr. Hooper also briefly summarized the ridership data for the other five regional express routes and noted that notwithstanding the broader economic challenges, that the Rock Hill Express is operating second only to the Concord Mills route.

**C. SCDOT Report** - Mr. Klauk presented an update on current TEP and CMAQ projects. Specifically, Mr. Klauk stated the Springhill Farm Rd. project is in the process of ROW acquisition; Mt. Gallant / SC 161 is on schedule for ROW acquisition; the SC 5 bridge project is on schedule; and the US 21 bridge is on schedule and due for completion in 2013.

Commissioner Nuckles inquired if the ROW acquisition on the Mt. Gallant / SC161 project could be expedited. In response, Mr. Klauk cited the Uniform Act and stated this process is dependent upon the negotiation process.

#### **4. REPORTS AND PRESENTATIONS:**

**A. Presentation on Grant Program Coordination** – Mr. Hooper presented information regarding the requirements and processes associated with grant programs supported with federal funds. Specifically, Mr. Hooper reviewed the annual application process for both the Transportation Enhancement and Congestion Mitigation & Air Quality Improvement Program(s). Mr. Klauk then briefly summarized SCDOT's project development process. Specifically, Mr. Klauk reviewed preconstruction activities such as preliminary engineering; environmental documentation and permitting as well as ROW acquisition and concluded by noting that this process is typically completed in 2-3 years. Additionally, Mr. Klauk briefly reviewed a number of the laws / procedural requirements that are applicable to project development and implementation activities.

Mr. Norman, Mr. Bowman and Commissioner Nuckles offered comments on the RFQ process as a general matter and related federal funding requirements. Mr. Hooper and Mr. Klauk then addressed additional comments regarding the important role that the Local Public Agency (LPA) election has on the length of a project's implementation.

Following this discussion, Mr. Hooper outlined a few opportunities for improving the time associated with prioritizing, funding, and implementing TEP & CMAQ projects. In particular, Mr. Hooper suggested initiating the annual application process in January versus March would be a logical place to start. Mr. Hooper went on to state that incorporating a requirement for front-end coordination with SCDOT during the application development phase; specifically, reaching general agreement on a project's scope and cost estimate, should aid in reducing the amount of time devoted to the administrative aspect of project implementation.

Mr. Reno then made a recommendation to form a subcommittee or study group to review the current governing laws of the grant programs in an additional effort to identify other areas that could make the process more efficient as well. Chairman Funderburk requested staff to

follow up at the next meeting with the best strategy to identify and review inefficiencies in the current laws.

**5. PROPOSED POLICY COMMITTEE ACTION ITEMS:**

**A. FY 11-12 CMAQ Projects** – Mr. Hooper presented a request for consideration of the air quality benefit analysis and final approval / submission of the following CMAQ projects totaling \$1,006,555.00 in federal funds to SCDOT and FHWA:

- 1) Springfield Pkwy Area Improvements – Town of Fort Mill
- 2) Traffic Signal Controller Upgrades (Ph IV) – City of Rock Hill
- 3) Electric Vehicles & Recharging Infrastructure – Town of Fort Mill
- 4) Heckle Blvd Sidewalk Improvement – York County

Sen. Hayes made a motion to grant final approval and authorize submission of the CMAQ projects totaling \$1,006,555 to SCDOT and FHWA. Mr. Norman seconded and the motion passed unanimously.

**B. TIP Amendment** – Commissioner Nuckles inquired about the \$550,000 increase in the cost estimate for the 2007 CMAQ project - SC 160/ US 21 Intersection Improvement. Mr. Klauk identified changes in the scope of the project as a factor in the increased cost. Additionally, Mr. Hooper noted SCDOT placed the project on hold while an evaluation of the LPA implementation process was completed, and cited fluctuating material costs as additional factors in the increased cost. Mr. Hooper also noted that this project was identified as a priority project in the 2004 Congestion Management Study. Following discussion, Mr. Hooper then presented a request for final approval to amend the FY 09-15 TIP to add \$550,000 in CMAQ funds to the SC 160 / US 21 Intersection Improvement project and for authorization of a 15-day public comment period.

Sen. Hayes made a motion for final approval to amend the FY 09-15 TIP to add \$550,000 in CMAQ funds to the SC 160 / US 21 Intersection Improvement project and authorize a 15-day public comment period. Mr. Bowman seconded and the motion passed unanimously.

**C. 2035 Long Range Transportation Plan (LRTP) Amendment** – Mr. Hooper presented a request for final approval to amend the 2035 LRTP to reflect an identified funding source for Phase II of the Celriver Road widening project. Mr. Hooper noted that no public comments have been received. Commissioner Nuckles made a motion to grant final approval to amend the 2035 LRTP; Mr. Reno seconded and the motion passed unanimously.

**6. OTHER BUSINESS:**

**A.** Mr. Hooper presented information on the completed evaluation of the Public Participation Plan. Commissioner Nuckles requested the addition of the local chapter of the NAACP to the email distribution list for public participation activities and notices. Mr. Bowman requested that RFATS display signs in the project areas to increase public awareness. Mr. Leazer stated the RFATS logo can be included on the Pennies for Projects signs.

**B.** Mr. Hooper noted staff completed an administrative adjustment to the FY 09-15 TIP on allocated CMAQ funds programmed and expensed in 2012.

**C.** Next regular meeting – November 18, 2011.

**D.** Mr. Hooper stated that the CMAQ allocation for RFATS, the only nonattainment area in South Carolina, should remain stable with respect to the 1997 ozone standard. Mr. Hooper then noted that EPA has withdrawn their request to lower the 2008 ozone standards. Ms.

Bell then stated that she recently received information from DHEC regarding the application of the 2008 ozone standard and a revised recommendation they are preparing to submit to EPA later this fall.

**Call to Order & Introductions**

Mr. Hooper called the meeting to order at 1:35 PM and welcomed everyone in attendance. Mr. Hooper then introduced himself and asked everyone else to do so as well.

**Review of Minutes**

Mr. Hooper asked if there were any additions, corrections, or deletions from the August minutes. Hearing none, the minutes were approved as presented.

**Old Business**

**A. Policy Committee Follow-up (August 12, 2011)**

**1. New Catawba River Crossing Feasibility Study** - Mr. Hooper stated that the Policy Committee – following a lengthy discussion regarding the applicable federal and state laws on the qualifications-based selection process – authorized the execution of the contract with STV in the amount of \$199,573.

**2. Draft Amendment of 2035 LRTP** – Mr. Hooper stated that the Policy Committee gave preliminary approval to amend the 2035 LRTP to reflect the identified funding source for Phase II of the Celriver Widening project. The amendment is currently out for public review and will be considered for final approval at the September meeting.

**B. Status of US 21 BRT Land Use Coordination and Service Implementation** – Mr. Hooper noted the adoption of the Land Use Implementation MOU by York County and the expected action by the City of Rock Hill in Fall 2011. Mr. Cronin then noted that the Town of Fort Mill's recently initiated an update to their Comprehensive Plan; and that, this item would be addressed during that process.

**C. FY 2011-12 CMAQ Applications, DOT Cost Review, and AQBA Results** – Ms. Shealy stated that the cost review is pending completion this week.

**D. Status of TEP / CMAQ Projects & Upcoming Quarterly Reports** – Ms. Shealy stated that a status report will be sent out no later than Friday, September 9<sup>th</sup> and asked that everyone update their projects as appropriate. Ms. Love then noted that York

County received a signed agreement with SCDOT for the SC 160 / Gold Hill Rd. project. Additionally, Ms. Love noted the adverse impact of current economic conditions and stated that York County is working to identify funding support for the portion of the local match originally proposed by a local developer at the initiation of the project.

Mr. Cronin then commented on the SC 160 / US 21 Intersection Upgrade project. Specifically, Mr. Cronin stated that this project was approved for 100% funding in the amount of \$400,000 in CMAQ funds in 2007. The most recent cost estimate to complete the project has been revised upward to \$975,000. Mr. Cronin stated that ROW acquisition is estimated at \$320,000 but noted the possibility of a discount or donation of some ROW by a property owner. Mr. Cronin then presented a request for consideration of an additional \$400-500,000 in CMAQ funds to move the project forward. Mr. Hooper added that this project has been idle for over four years and has been identified as a priority in the 2004 CMS. Members had no comments at this time.

- E. Status of Lake Wylie Bus Study** – No new activity to report.
- F. New Catawba River Crossing Feasibility Study** – Mr. Hooper spoke about the formation of a project team for the feasibility study; specifically, identifying staff in addition to the Study Team, that should be included in this process? Members expressed their support of additional non-planning staff for the project team. Mr. Hooper then requested names and contact information for the staff to be considered and stated the initial project team meeting would be scheduled for the end of September or beginning of October.

Mr. Shaw inquired about the participation / involvement of the project team. Mr. Hooper stated the project team would provide first hand knowledge of the area and serve as a review body for the duration of the study.

- G. Report from Catawba Region Regional Transportation Management Association** – Due to Ms. Bell's absence, no report was presented.

## New Business

- A. Policy Committee Agenda Items for September 23, 2011**
  - 1. Study Team Reports** – Mr. Leazer will present a Pennies for Progress update; Mr. Klauk will provide an SCDOT report; Ms. Shealy will present the quarterly TEP / CMAQ report; and Mr. Hooper will present the quarterly transit report.
  - 2. FY 2011-12 CMAQ Project Applications and AQBA Approval** – The FY 2011-12 CMAQ projects will be presented for final approval at the September meeting.
  - 3. Adoption of Amendment to 2035 Long Range Transportation Plan (LRTP)** – The amendment to the 2035 LRTP identifying the funding source for Phase II of the Celriver Widening project will be presented for final approval at the September meeting

**4. SC 160 / US 21 CMAQ Project** – Mr. Hooper confirmed that a request for additional funding will be presented at the September Policy Committee meeting.

- B. Presentation on Grant Program Coordination** – Mr. Hooper stated that Mr. Klauk will present a report on the grant program process and coordination between project sponsors and SCDDOT. Additionally, Mr. Hooper noted that a proposed change in the CMAQ schedule to begin in mid-January versus mid-March will be initiated for the FY 2012-13 funding cycle.
- C. Public Participation Plan (PPP)Review** – Ms. Welch presented information on the PPP review. Specifically, the consensus report (2008 to present) which summarizes each public participation activity / techniques used and the results of the PPP survey posted on the RFATS website. Survey respondents identified the use of social media, internet and local town channels as other tools / techniques to utilize for public notifications. Mr. Cronin suggested broadcasting a video explaining RFATS and its role in the community on local town channels. Mr. Chorak also suggested posting signage in the area of RFATS projects.

Additionally, Ms. Welch noted the addition of Google™ translate to the RFATS website. Ms. Welch stated future public notices will be posted in both English and Spanish. Ms. Hekter noted the need to verify the translations.

### **Other Business**

- A.** Mr. Hooper stated that a letter of endorsement from RFATS would be provided to the Centralina and Catawba Regional COGs regarding the Sustainable Communities Planning Grant.
- B.** Mr. Cronin inquired about the adoption of a transportation improvement overlay or preservation ordinance following the passing of the 2011 Pennies for Progress program. Ms. Love indicated York County has an ordinance in place; some jurisdictions may not. Ms. Britt commented on an amendment of current ordinances to reflect the 2011 Pennies for Progress program.
- C.** Ms. Hekter had no additional information on the transportation reauthorization and federal gas tax status.

**6. TIP Amendment** – Mr. Hooper stated the Policy Committee granted final approval to amend the FY 09-15 TIP to add \$1,500,000 in FY 11& 12 Guideshare funds to SC 121 / Albright Road widening improvements (1997 Pennies for Progress project).

**7. FY 2011-12 CMAQ Project Recommendations** - Mr. Hooper noted that all Air Quality Benefit Analysis (AQBA's) were received by the August 1 deadline; results will be distributed to Study Team members for review; and will be presented for final review at the September meeting. The SC DOT cost review is still pending at this time.

**B. New Catawba River Crossing Feasibility Study RFQ** – Mr. Hooper reviewed the solicitation process and summarized the three points of discussion for the August 12 meeting of the Policy Committee; specifically, the qualifications-based selection process; prior project costs versus funds allocated; and prior qualifications-based RFATS projects.

## New Business

**A. Policy Committee Agenda Items for August 12, 2011**

**1. Amendment to LRTP** – Mr. Hooper reviewed the Celriver Road widening project; and specifically discussed the need to amend the Long Range Transportation Plan to reflect funding for both phases of work from US 21 to Dave Lyle Blvd. Although funding is currently provided for phase I; FHWA has requested that an indentified funding source for the entire corridor (i.e., Phase II), needs to be reflected in the LRTP as well; this item is slated for initial review at the August Policy Committee meeting.

**2. TIP Administrative Adjustment** – Mr. Hooper stated the addition of Springfield Parkway (2003 Pennies for Progress project) is now reflected in the TIP and will be noted at the September meeting.

## Other Business

**A.** Mr. Cronin inquired about the possible expiration of the SC gasoline tax. Ms. Hekter will research and provide information at the next meeting.

**B.** The next Study Team meeting is scheduled for September 1, 2011 at 1:30 pm.




